WATERWATCH REPORT

As you may or may not be aware, within the Association "Waterwatch" is responsible for all matters pertaining to the canals and systems associated with water, and vessels into and out of the canal. It is important that we all maintain a good clean water system.

There have been three main issues for Waterwatch since the last newsletter, two of which have had some coverage within the local press:-

(a) The suggested development of Chaplin Park for a Council owned and managed or operated boat ramp. This facility is expected to have more than a single ramp with parking spaces for a considerable number of vehicles with trailers.

Noosa Waters Association has made a submission to Noosa Council against this proposal on the basis of boat congestion and pollution. There is potential for an increase of pollution resulting from accidental spills of motor oil and from detritus from fishing activities. A boat ramp positioned so close to the pumps that pump 17 million litres of water into the canal nightly is highly likely to increase pollution in our waterways.

The proximity of the Yacht Club to our canal/river access already presents some problems in this busy reach of the river, and to add further congestion would increase the danger of collision and be a safety risk. We very much hope Council will reject this proposal.

(b) 3 years ago we had discussions with Council regarding the increasing water run-off from within our Noosa Waters catchment area, bordered by Mary St, Noosa/Tewantin Rd, Eenie Creek Rd and Reef St. Our concerns relate to potential pollution and "flash" floods. At that time we received satisfactory assurances, but with building development now accelerating within the catchment we again intend to have further discussions with Council. Water levels rose above the revetment wall during a downpour and we do not want the situation to get worse.

© Noosa Waters jetties, pontoons and boat lifting devices and their compliance or otherwise with regulations has been well publicised recently in regard to proposed action by Council. The Association supports Council in implementing their policy but we also support technical evolution and common sense and are asking Council to consider a review and update of the policy. Council are likely to require residents who have serious breaches to remedy or remove structures.

Current legislation for building a jetty in Noosa Waters is document **PSP25 Domestic Marine Uses in Noosa Waters** found on the Noosa Council web page Planning and Development, Publications. If you have a jetty that you are unsure whether it is legal possibly because you have recently purchased a house, the council can advise if it was submitted and approved.

Finally our attention has been drawn by a letter to the editor recently to the liability parents may incur through public liability claims if their child has an accident driving a powered boat. Complaints have been made about speeding in the canals and unlicensed craft. Children can have a lot of good clean fun playing around with boats, so let's keep it that way.

NOOSA SMARTCABLE

The underground cable TV service was designed and installed for the Noosa Waters Estate developer Noosa Waters Pty Ltd. as a service to be offered to all home sites on the estate. The purpose was to encourage the development of a premium quality estate in every aspect which would include no above ground electrical power, telephone lines or external TV aerials.

From initial development up to November 2004, the system was maintained by CATV Cable and Design and Installation Pty Ltd. Noosa Smartcable purchased the system from CATV in November 2004 and continues to maintain the system today. Since taking over the system Noosa Smartcable has made a considerable investment in updating ageing equipment and improving the quality of service provided, some of this investment includes;

- Installation of air conditioning in Skipper Place to maintain optimum temperatures of electronic equipment
- Insulation of Skipper Place premises
- Upgrade and installation of 5 new amplifiers

The system is constantly monitored to ensure that signals continue to be provided at optimum levels. As a result of the work carried out Noosa Waters now experiences an excellent service.

We are currently conducting reception tests for the Brisbane DIGITAL signals for channels 7, 9 and 10. This has required the installation of additional equipment including aerials and modulators to send the signal along the cable. When tested successfully we will provide the digital signals to our customers at no additional cost.

We take this opportunity to thank our Noosa Waters users for their ongoing support of the system.

A FRIENDLY REMINDER

COUNCIL PARTNERSHIP

For those new to estate, I thought it would be helpful to touch base on the partnership.

In 2000 the developer left the estate and most of the responsibilities, particularly the parklands and waterways including the lock, were handed over to Noosa Council. This was a major change for the estate, as it went from a private company to a semi government council. This meant that we now had to deal with various departments and were subject to council budgets. Some residents recognized the difficulty council would have in maintaining the high standard of landscaping within the parks. So the KEEP NOOSA WATERS BEAUTIFUL GROUP was formed. This group joined the residents association in 2000 and is known as the landscape group. In August 2000 a partnership was formed with council. In return for our voluntary help in maintaining the estates parks and waterways, council would allocate a maintenance budget which would be managed by the association. The aim of the association and the residents is to have the best possible relationship with council, and to work together to maintain and improve the appearance of the estate. This is especially important now that the estate has reached ten years of age. I am pleased to say over the years we have developed a strong working relationship with the many divisions of the council.

XMAS-TIME

As we prepare for Xmas socializing, can I ask everyone to be mindful of their property and ensure your empty bottles and rubbish are secured in the garbage bins. Neglected bottles etc. sometimes end up in the canals through the storm-water drains by people being irresponsible. Remember, people swim and fish in the canal.
