In the period since the last newsletter your Committee has been active in dealing with a number of local issues, antiamalgamation and Charter issues.

The Partnering Charter with Noosa Council will hopefully move with us to the new council. Certainly, that is our understanding of the proposed action and recommendation from Noosa Council's interim management group. This cannot be guaranteed (the new council has to adopt recommendations itself and cannot be bound in advance) but the model is a living example of good government and active community and council partnership. As a resident the Charter offers us all a terrific set of working guidelines that maintain the beautification and liveability of this estate in partnership with Council. This is a unique feature of Noosa Waters and one to be highly valued. If you want a copy just email overlord@bigpond.net.au

The Web Site sub-committee has been considering the structure, content and functionality of our first web presence. Included with this newsletter is a request for your financial support – a Special Levy per property – to get the site operational early in 2008 (March). A web site will facilitate fast and more detailed communication with your residents association. Membership services on-line are now commonplace and we should move to also have this facility for payment of dues, emails to Management Committee members, access to special reports for waterways, landscaping and security among others. Already a number of interested residents have contributed to the web fund with generous donations. Join them in creating this window into estate management and residents involvement in underpinning and growing property values. A printed Newsletter will still be provided as some do not have computers or internet access / experience.

As from 1 January 2008 any new applications for membership will be at the new rate of \$20 pa. Your committee have also decided to move the Association to a Level 2 category association thereby allowing us greater capacity to improve services to all residents. The benefits over the coming years outweigh the reporting requirements. Under a new super council we believe that the Noosa Waters Residents Association has to strengthen its role and involvement so that we maintain our impact with local government. To fund new initiatives, the committee believes that the current subscription fee is too low. Additionally, many residents see the small amount as a nuisance. Moving to a sensible fee and internet payment is warranted. We recognise that some on the estate do have to budget but the benefits in a higher fee are substantial and worthwhile. \$20 pa is unlikely to break the majority. We reserve the right to request consideration of a Special Levy for special projects – like the web site. This is a partial move to user-pays and a more realistic operational base. Along with these service and operational improvements, the

Committee is seeking new minds to add to the value the current committee brings. We are all volunteers who share roles and get involved in activities that interest us or create challenges to be addressed. We seek involvement by up to three (3) new members who see their backgrounds, experience and personal preferences covering any of the activities of the Noosa Waters Residents Association – social, facilities and services, government and resident issues. Call 07 5474 2925 to discuss your interest. Many elements of what you see, experience and what attracts you to live in Noosa Waters has arisen from the efforts of successive Noosa Waters Residents Associations and their committees. The current committee is asking for your support.

Membership and subscription levels are under what your committee believes is truly representative of a majority of residents. In the 1st quarter 2008 we will promote a series of Meet Your Committee gatherings across Noosa Waters to provide a forum for residents to hear directly from the committee and President on matters concerning the effective and efficient management and administration of the estate. Look out for the reminder and venue flyer carrying the association logo. If any resident member is aware that a neighbour isn't a subscriber, please encourage them to attend with you and get more facts and information about the benefits of membership.

New initiatives are underway being the web site, discussions about security and anti-hooning initiatives. We are also considering expanding social interaction. Our work with the new council will be critical to maintaining services. We are working

#### WATERWATCH REPORT

#### 1. Introduction

Since the last newsletter Noosa experienced a flood where the Noosa River burst its banks. This caused severe flooding along parts of Gympie and Hilton Terraces. It was found that Noosa Waters stood up very well to the flooding. Water did not enter any houses but rose above the revetment wall by approximately 455 mm. There were homes in Shorehaven Drive close to the wetlands where water flowed over the road. Waterwatch has made a submission to council requesting council undertake a study/investigation for the Noosa Waters catchment area particularly regarding present and proposed developments.

- 2. Short Brief of August 2007 Floods, and the Effect on the Noosa Waters Lake System  $\,$
- 2.1 Rainfall on Noosa and the Cooloola Coast

The total rainfall for the week ending Sunday 26th August according to the Bureau of Meteorology (BOM) was:-

- Rainbow Beach 941mm
- Noosa Heads 803mm
- Tewantin 616mm
- 2.2 The Rain Recorded on Noosa Waters

Noosa Waters received unusually heavy rain for August in the early part of the week. Rainfall commencing 20th August 2007, was as follows -

- For the 24-hour period ending 9.00 am on Monday 20th 42 mm
- For the 24-hour period ending 9.00 am on Tuesday 21st nil
- For the 24-hour period ending 9.00 am on Wednesday 22nd 70 mm
- For the 24-hour period ending 9.00 am on Thursday 23rd 50 mm

The BOM stated that a low-pressure trough, off the coast of Fraser Island, had become stationary due to a high pressure area over Bass Straight in Victoria. This caused rainfall over the Sunshine Coast at levels that had not been recorded in August since 1880.

- For the 24-hour period ending 9.00 am on Friday 24th 400 mm. This raised canal levels to 0.1m above the revetment walls, or 0.5m above its normal water level. At the same time the Noosa River at Noosaville was not flooded and was still about 0.33m below its banks. However the Noosa River broke its banks that afternoon.
- For the 24-hour period ending 9.00 am on Saturday 25th 215 mm

The lock gates were opened, Saturday, until the following Wednesday 26th. The weir/lock level was indicating 3.5 m on the lock wall at 2000 hrs, Saturday. 25/8/07.

This was the 4th time in 14 years that the canal water had come above the revetment walls. It was the highest level reached in the history of Noosa Waters.

We were verbally advised that there could be some sewage 'feedback' in toilets.

2.3 Preliminary Discussions with Council

Conversations with Council representatives on the worst case scenario of a cyclone, with an off-shore storm surge occurring, were reassuring because of historical data.

#### 3. Proposal for a Consultant's Flood report for the Noosa Waters Estate

It is proposed that NWRA WaterWatch enter into discussions with Noosa Council to appoint a suitably qualified consultant to prepare a flood report for the Noosa Waters Canal Estate. The facts and observations of the August 2007 floods are to be taken into consideration together with forecast scenarios of future flood situations. Brief details of NWRA requirements to Council are as follows:

- a. Calculations of all flash flooding are required from all catchment areas feeding into the Noosa Waters Lake system. The current situation is likely to deteriorate particularly as the hard surface building developments on the boundary of the NW catchment areas have not yet been completed.
- b. Consideration of having lock gates opened at times deemed appropriate to relieve flash floods. Safety and supervision to
- c. Report required on the effects of the various types of floods on Noosa Waters i.e. flash, river volume, tidal and storm surge. Typically these occurrences would be caused by cyclonic and other adverse heavy rain/storm events. NWRA to make available to any selected consultant all collected data.
- d. Council to arrange a one-off consultant's report to be prepared, taking into consideration the information available from the designer of the estate.
- e. Council to maintain clear passage for water entering the Shorehaven Drive road wetlands underpass by regular clearance of obstructions.
- f. NWRA to advise residents best method to secure vessels and associated equipment.
- g. Where possible all absent owners to have an arrangement with a neighbour or friend to care for their property.
- h. Council to commence monitoring of the 4.5 m setback from revetment walls of 'structures or obstructions' to ensure the design integrity of the lake system is maintained.

#### 4. Action Plan

Detailed documentation has been prepared and issued to the Council executive and Councillors requesting a flood investigation/study be undertaken by a suitable consultancy for our requirements. A meeting has been arranged for NWRA to meet with Council to discuss these requirements.

## POTENTIAL FOR SHARK PRESENCE IN CANAL SYSTEM

Since 1993, when the Noosa Waters canals were connected to the river, there have been numerous alleged sightings of sharks in our canal system. In that time, no proven shark presence has been evidenced despite investigation and enticement to bait. That is not to make light of what are a regular number of sightings, some quite recent this season.

Residents of Noosa Waters need to acknowledge that the canals are Queensland waterways and therefore sharks could be present. Noosa Council advice is that the lock system would be a significant challenge to any shark entering the system. However, neither to our nor Noosa Council's knowledge, has there ever been a confirmed proven sighting, capture or attack within the Noosa Waters Canal System. Notwithstanding this residents should use common sense when fishing, swimming or playing in the canals. Noosa Council is prepared to take action if a substantiated presence can be evidenced. Council is happy to receive evidence of sightings.

Since the annual general meeting the following has taken place:-

- The removal of allocated trees from the estate
- Arranged replacement trees
